**THE FARM SERVICE AGENCY (FSA) CHESHIRE-SULLIVAN COUNTY COMMITTEE PROPOSES
CHANGES TO EXISTING LOCAL ADMINISTRATIVE AREA (LAA) BOUNDARIES**
Comment Period Open April 1 through April 15, 2015

The Cheshire-Sullivan County FSA Committee has proposed changes to Local Administrative Area (LAA) boundaries in Cheshire & Sullivan Counties. The changes were necessary to better distribute eligible voters in the areas. The proposed changes are open to public comment for 15 calendar days, ending April 15, 2015. Comments should be submitted to the Cheshire-Sullivan County FSA Office in Walpole, NH.

LAA 1 – Plainfield, Grantham, Springfield, Cornish, Croydon, and Newport

LAA 2 – Claremont, Charlestown, Unity, Sunapee, Goshen, Lempster, Washington

LAA 3 – Acworth, Langdon, Walpole, Alstead, Marlow

LAA 4 – Westmoreland, Surry, Keene, Gilsum, Sullivan, Stoddard, Nelson, Harrisville, Roxbury, Marlborough

LAA 5 – Chesterfield, Swanzey, Troy, Dublin, Jaffrey, Hinsdale, Winchester, Richmond, Fitzwilliam, Rindge


Towns that were affected by the proposed changes include Newport, Lempster, Washington, and Dublin. Since five areas were affected by the changes, 2015 FSA County Committee Elections will be held in LAA 1, 2, 3, 4, and 5.
